EU-RoHS 2 Compliance

The majority of Southco products are compliant with the EU-RoHS 2 Directive (2015/863/EU). Packaging for compliant parts are marked "RoHS COMPLIANT". Certain Southco products are excluded from RoHS compliance typically to meet the needs of regulated industries that prohibit material changes such as aerospace.

EU and UK REACH Compliance

European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) identifies "Substances of Very High Concern" (SVHC). The most up to date information on covered substances is available through the European Chemicals Agency (ECHA).

Health and Safety Executive (HSE) has impletemented UK REACH in Great Britain (GB) effective from 1 Januaray 2021. Southco has a facility in Worcester, UK, which falls under GB territory. For UK manufacturing products (article) we have confirmed UK REACH compliance considering grandfathering effect of registration process from concerned suppliers.

Under the structure of the REACH Regulation, Southco is a manufacturer and supplier of "articles". We do not manufacture or supply "substances" or "preparations" and our articles do not involve the "intentional release of substances". Accordingly, we foresee no registration or pre-registration requirement for the products we supply. Southco products (articles) do not exceed the threshold value for any SVHC declared by ECHA as of **June 27, 2024 with 241 SVHC** and **HSE** updated as of **Dec 16, 2021**.

The information provided here is on a "best effort" basis using the information provided by our suppliers, published data, and documentation from regulatory authorities. No attempt has been made to verify this information by third party analysis.
